On Section B - Specification Item 4. it states "Contractor shall install a "Like for Like" replacement of the failed existing system(s) with a completely functional new system.

And Section 4.5.1 paragraph 2 & 3, it states "Provide and Install new 16 SEER 7.5-ton, 230-volt, 1 PH, 60 HZ Heat Pump split system(s) with R410A refrigerant to meet all current codes and regulations, Installed systems combinations must meet the minimum SEER rating, shall perform equivalent to the existing unit(s) and system capacity, and must fit in the existing mechanical space(s). The components of the new system(s) shall be performance matched and shall be products of the same manufacturer. Acceptable manufacturers: York, Lennox, Carrier, Trane, RHEEM, Ruud, or approved equal of equivalent quality and performance

A1: TPWD will accept an approved equivalent.

Q2: The existing units DO NOT have Heat Pumps. Only Auxiliary Electric Heaters were present. Do you want us

to include Heat Pumps in our bids or do we bid what is existing without heat pumps? see item below.

Section 4.5.1 Paragraph two states "Provide and Install new 16 SEER 7.5-ton, 230-volt, 1 PH, 60 HZ Heat Pump split system(s) with R410A refrigerant to meet all current codes and regulations."

And Section 4.1,4.2,4.3 & 4.3 list the existing units with no heat pumps, only auxiliary electric heat.

A2: New Heat Pumps should be included.

Q3: After review of the specs and trying to price them, the parts to the units can be warrantied up to 10 years, but the compressors are only warrantied for 5 years with no option to buy extended warranty. Is this ok with TPWD?
